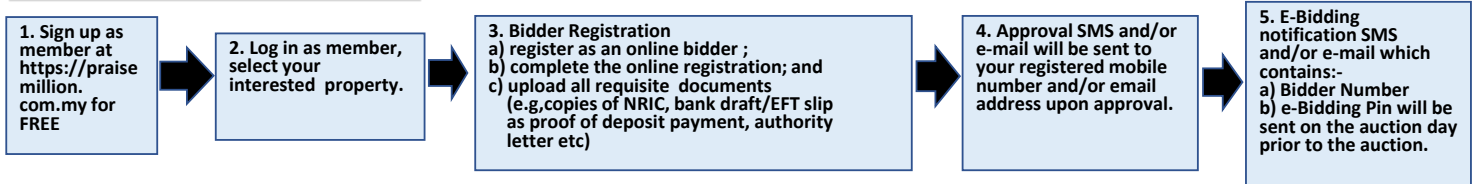

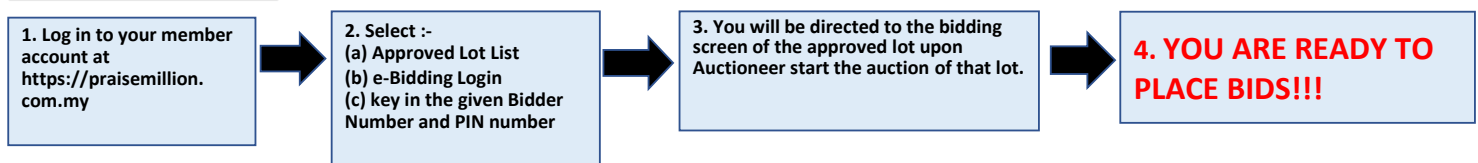


HOW TO REGISTER AND BID ONLINE?

ONLINE BIDDING STEPS



◊ Online bidding can be done using a computer, notebook, smart phone or tablet
